Fall 2022 OCDA Treasurer's Report

- Checking Register
- Savings Register
- 7 Day CD Register
- 2022 Summer Conference Report
 - 2022 Summer Conference currently made \$765.78 compared to making \$2,694.18 in 2021.
 - Income was impacted by:
 - Increase in conference registration
 - Graduate hours outstanding
 - Expenses were impacted by several factors
 - PayPal/Constant Contact Fees
 - Student help (reduced)
 - Reading Session Music
 - Facility fee
 - Income and Expense items reflect a large drop in revenue with a lesser reduction in expenditures.
 - Income increased (\$14,590) and expenses increased (\$16,518)
 - Fee for conference was held the same as previous years.
- 2022 CHC Report
 - Cancelled for 2022
- 2022 HSHC
 - 2022 HSHC lost \$432.54 compared to making \$0 in 2021.
 - Various expenses saw slight decreases contributing to the overall decrease in expenditures
 - o Participation was 130 in 2017, 117 in 2018, 126 in 2019, and 63 in 2022.
 - Venue rental was a net drag on the event—without it the event would have been in the black.
 - Operating margins are increasing; we need at least 70 students to break even based upon these costs
 - The participation level will drive the trajectory of this event in the future.
- YTD Income vs. Expense Comparison
 - In 2021, we received \$2,996.58 more than we spent and in 2022 YTD, we've spent \$1,815.28 more than we spent. I do expect there is at least \$1,700-\$2,000 worth of revenue to be received yet.
 - Member deposits are up (conference)
 - o Income increased across the board
 - Expenses increased more than income (\$4,800)
 - Insurance is an added financial commitment already noted by the Board
 - Sponsorships were not utilized this year
 - Summary Items
 - We (should) break even this year or end up slightly in the black!
- 2022 Spending Pie Chart
 - Shows Top 10 spending categories

- Sponsorships for FY 2023 are unallocated
- W-9s and 1099 Misc
 - We are responsible for filing these as OCDA

Mentorship Chair Report OCDA Board Meeting Saturday, Sep 10, 2022

- 1. Spoken with Sundra Flansburg about what ACDA does for Mentorship at the National level. Hilary Apfelstadt assisted in making this connection. Thank you Hilary.
 - 1. You'll find the mentoring website at https://mentoring.acda.org/.
 - 2. We have registrations for both mentors and apprentices about 80 plus of each. That's a good mentor pool to search, and a great number of members seeking mentors.
 - 3. The program is apprentice initiated, and anonymous until each of the partners accepts the match. With this re-launch, there are many tools on the platform for users to schedule meetings, utilize resources, etc.
 - 4. Almost all mentoring partnerships schedule online sessions with each other. Apprentices can search by general geographic areas, but most tend to look for fields of interest and work without respect to geography. A fair number try to meet up in person at our conferences, if both are attending. I think all of us are more skilled and willing to do online sessions than we may have been a few years ago (or the opposite!).
 - 5. A new feature in this relaunch version is Communities We can set up communities especially for specific groups to allow them to dialogue, ask questions, and respond to each other. We have communities set up for Students and Early Career Educators right now. We could set one up for Ohio members, if that would be interesting for you. From past experience, it takes some offline encouragement and online facilitation to move people to those groups, and encourage interaction.
 - 6. The program is obviously free to all members.
- 2. Doug O'Neal informed me that previous OCDA board discussions also included appointing specific individuals that are experts or specialists in specific repertoire styles etc. that mentees could reach out to as resources for appropriate repertoire. Resource list more specific.
- 3. Hilary shared a list of retired OCDA Clinicians or those that would be interested in being a mentor. The list is not very big so this area could use expansion.
- 4. I have begun a list of first through third year teachers that are interested in our mentorship program and plan to reach out to various colleagues at the university level to compile a list of their recent graduates who may be interested as well.

Today's OCDA Trivia Moment is from October 1968 and was written by Ernest Hisey:

Why ACDA?

"A constant question thrust at ACDA members is, "why should the organization exist?" "What use is the ACDA in Ohio?" If we have to go out and find a need or reason for our existence, then it would seem a questionable existence indeed. ACDA in Ohio provides a rallying point and an organizational support for church, school and community choral directors. Providing aid in choral technique and problems to choral directors throughout our communities is a prime way to raise the level of the choral art in our state. Read again Article 1, Section 3, of our state constitution: 'The purpose of this state organization is to offer an active, localized program of specialized assistance to choral directors, to foster and promote the highest level in artistic ideals, standards, techniques, musicianship, and materials for choral music in schools, colleges, churches, and with communities.'

As OCDA (as it is now named) progresses, we should be grateful for those who came before us and paved the way to the great benefits we now experience in this wonderful organization! Thank you, Ernest Hisey, for reminding us of our deep roots and rich history!
