

ACDA at the OMEA Convention, Cleveland:

The choral reading session conducted by Ohio ACDA, with 200-250 participant, was quite a success, both music- and membership-wise. It is proving to be a fine cooperative venture for both organizations. Our thanks to ACDA-OMEA Neil Zimmerman who coordinated the session, to our members who directed, to Music Educators' and John Stavach for furnishing the music, and to Byron Griest who presided unexpectedly and well at the three-legged harp.

ACDA to the front: Our collective hearts should swell a bit, knowing that so many of the choirs which sang for the various sessions were directed by our own ACDA members. They included Mary Eileen Fogarty, Bill Fenton, Daniel Moe, John Wrabel, and John Williams. Ohio director-composer (also an ACDAer) John Carter had some of his compositions performed.

Of particular interest to us in ACDA were the sessions by Gregg Smith and his wife who sang and discussed choral music of Charles Ives and of early America. It's nice to find another well-known choral director with a good "cause" who is a delightful human being as well as a respected authority in the field.

ACDA at its own Convention, Kansas City:

When you attend the national convention at K. C. you agree with president Larry Tagg whose reaction to the whole thing was "I feel that ACDA really is something special."

Apparently others thought the same thing. While official count was not available, the attendance was circa 2000— way above that of two years and a rewarding proportion of the total membership.

Ohio was well represented, too. Along with Fres. Larry, I saw Bruce Brown, Maurice Casey, John Drotleff, Fred Fusco, Paul McGill, Daniel Moe, and Bob Petty. Loretta Conrad and Tim Morris participated in the DIRECTORS' CHORUS under Robert Shaw. Did I miss anyone who was there?

The DIRECTORS' CHORUS, by the way, took no back seat to <u>any</u> of the performing groups. At the first rehearsal under Shaw the group sang one chorus of the <u>German Requiem</u> and one wondered what needed to be rehearsed! Shaw did, and how he rehearsed! What insight! What meticulous attention to detail as well as to the whole! What self-subordination! Thank God he hasn't escaped the choral field completely!!

The program included a variety of facets of choral music: a session on Barbershop (honest!), two on "Black Choral Music: Where It's At!", one on gospel-testimonial music, and one by a small (in-tune-singing) pop group.

The really unique group was the Budapest University Choir, in native costume, brought to the States by the Council for Intercultural Relations which sponsors the annual summer Symposium in Vienna in cooperation with ACDA. The Choir's concept of sound is different, its repertoire is different, its conduct is different, and part of its performance (with dancers from within the group) is different. WE were different, too: we stood up, applauding -but rhythmically (a la Europe), watching with moist eyes and feeling the impact of Musik über Alles.

You must hear Kodaly's Jesus and the Traders, sung in its native language and by natives who should know the correct style of performance to get the real impact of the selection.

ACDA at the NC MENC Convention, Milwaukee:

I hope you had enough "bread" to attend-I didn't. I stayed home and sang the old song, "'Tis the Season to be Selective," as I sorted out my memories of K. C.

How can you be heard by ACDA of Ohio?

What is the status of the Honors Choir?

Its activities have been suspended for a number of reasons. While it functioned satisfactorily for a couple of years and represented us well at the NC MENC in Cincinnati two years ago, a number of questions of importance evolved while it was in operation. First of all, what is the real reason for its existence? To provide its members with musical growth not available at the local level? To be a guinea pig/clinic choir for the benefit of ACDA members at summer convention? To be the choral equivalent of OMEA'S All-State Orchestra? Or, exactly what?

Another question: Who should direct it—a "name" professional director? One or several of our own accomplished member-directors? Who gets paid for directing? How much? Where will the money come from?

The question of logistics: Where and how often will they rehearse? Who will be responsible for them in rehearsal and concert sites? Would you, personally, be responsible for your students—I am trying to avoid the word chaper one.

As an afterthought, but certainly not the final one: what about auditioning? Should we consider only the best singers???

We truly would like your reaction to an Honors Choir. Let us hear from you.
