In this issue you will find the program for the North Central Division Convention we are hosting at the Sheraton Hotel in Columbus March 4-6. I sincerely hope that you will be in attendance, not only to show Ohio's support of this great event but especially to take advantage of the many clinics and outstanding concerts.

During my affiliation with ACDA, I have often wrestled with these questions: what am I doing for choral music? what are we doing for choral music? and specifically, what is ACDA doing for its membership in choral music? Sometimes the answers to the first two questions are difficult to ascertain, but the answer to the third question is quite easy when one thinks of March 4-6. Ohio is proud to have several outstanding groups selected for this program. The combined choruses of Ohio State U. and Cincinnati College-Conservatory will present the final concert under the direction of Robert Shaw. We are grateful to Alice Parker for preparing the commissioned work and are especially happy that Mr. Shaw has consented to conduct on this special occasion.

Certainly you will want to attend every session! If you have not already done so, send in your pre-registration today. This form was included in the printed bulletin sent to every member last November; you will find another in this issue.

Following our midwinter Board meeting January 9 in Columbus, we will install president-elect William Hamilton as president of ACDA OF OHIO. This change, which was scheduled for July, is necessary because of the election of your current president to the position of president-elect of the North Central Division for the term 1975-1977. Bill comes to the presidency with a wealth of knowledge and experience, and I know he will give outstanding leadership to our organization.

As I leave this office, let me say how much I have enjoyed working with all of you on behalf of ACDA. You are fortunate inhaving a fine Board of Directors dedicated to aiding you in the choral art, making your work more effective and rewarding through the combined efforts of our entire membership.

OMEA CONVENTION -- ACDA READING SESSION

Our annual choral reading session is scheduled for Thursday evening, February 5. Chairman William Hamilton has arranged for 250 packets of music from many publishers. Conductors will be Don Hinshaw (Hinshaw Music Company) and Dr. James McKelvy (Mark Foster Music Company). R. Byron Griest will do the accompanying.

The session is from 8 to 10 p.m. in the Presidential Ballroom of the Neil House. Remember this is always a large and usually crowded event... plan to be there early, pick up music and help new people find a seat so we can get through all the music in the

allotted time.

Look for our ACDA OF OHIO exhibit, probably near the registration desk. This is a fine opportunity to meet old friends and make new ones.

ACDA OF OHIO is continuing promotion of student composition with a competition this spring for Ohio college students -- graduate or undergraduate. The work may be for any combination of voices, 3 to 6 minutes in length recommended; it must be a recent composition (1975-1976).

BICENTENNIAL CELEBRATION

July 19-24, at Interlochen, Michigan, national ACDA is presenting its special festival--an unusual bonus for members.

Each state has completed auditions to select a quartet for the chorus of 200 voices to be under the direction of Lukas Foss. Ohio chairman Dr. John Van Nice organized auditions last October. Each regional chairperson made a preliminary selection from tapes submitted by their region applicants. Finalists were given an extensive audition in Columbus by Marianne Cooper, Beverlie Mayer, James Myers, and Robert Stofer.

John Van Nice directed the Findlay College Choir in a concert of American music in November. John Williams was guest narrator-soloist for the BALLAD OF AMERICANS on this program.

John Van Nice is now embarking on a campus production of FUNNY GIRL.

John Williams presented two sessions on choral conducting at the Western Ohio Education Association all-day workshop at the University of Dayton in October.

Ernest Hisey's Avon Lake H.S. Chorale performed two new works by Frederick Koch at a November concert co-sponsored by the Cleveland Composers' Guild and Cleveland State University.

Dr. John C. Wabrick, director of choral activities at Miami U., is presenting a series of lecture-recitals with his Chamber Chorale. First on the series was THE SMALL SACRED CHORAL WORKS OF ANTON BRUCKNER. Two February programs are in the next column; the series will end with two programs in May.

The Miami U. Choraliers (Women) and Men's Glee Club toured several European countries in September, performing a wide variety of music for men, women, and the combined mixed chorus.
