WHO IS THIS MAN CAL ROGERS?



If you have never met him you are much the poorer. If you have musically participated under his baton either in orchestra or chorale you are much the richer. If you have served under him as a committee chairman or organization president you have been stimulated by a searching, pervasive mind to achieve what often seems impossible. If you have listened to him analyse a problem and find an answer you have heard a master of rhetoric and persuasion bring a simple understanding to the most perplexing question. If you have shared an experience with him you know both joy and sorrow more fully. If you can call him "Friend" you are among God's blessed for of such men is the Kingdom of Heaven made.

WHAT DOES HE MEAN TO OCDA AND ACDA?

Cal had been elected Editor of Triad for four years by OMEA. The editors convened before the national MENC meeting. Accidentally he dropped into one of the early meetings of a fledgling organization of choral directors. He liked what he heard and he was impressed with these people who were committed to producing and perfecting good choral music. He decided to join them. In the beginning there were only seven or eight members in Ohio, but they were enthusiastic sharers of their knowledge about the art of choral direction. This enthusiasm attracted others and so an active Ohio Choral Directors Association was formed and grew.

In the 60's Cal was president-elect, president, and vice-president of OMEA's 4000 members which meant putting off major ACDA offices until the 70's.

In 1970 he hosted a state conference for OCDA. In 1978 Maurice Casey was moved into Divisional Chairman and Cal filled out Casey's last year as OCDA president and went on to two more years as elected president. OCDA grew to 500 members.

This spring he was elected Central Division President-elect, a position he will not assume because of his move to Colorado. There is no doubt that Colorado ACDA chapter will find a use for his talents and be the richer for having him there.

WHERE DID CAL COME FROM AND WHERE HAS HE GONE--SO FAR?

Cal Rogers was born in Pittsburg, PA, the son of Joseph and Marie Rogers. As a boy he learned to play the violin. He attended Oberlin Conservatory and graduated in 1943. Then he took off for the European theater where he served under General Patton. When he returned he married his college sweetheart, Helen Noxon(Noxie), in 1946 and eventually they had three daughters, Sally Jo, Susan Elaine (Armstrong), and Deborah Anne (Ludwig) and now six grandchildren.

He completed his Master's degree in 1948 at Oberlin with a double major in violin and conducting and a strong minor in voice. He was appointed director of the Ashland College Choir during his final year at Oberlin and in 1948 became Head of the Department of Music, Ashland College.

From 1950-55 he spent much time working toward his PHD in Musicology. Then he was selected for the elite Masters Class of the famous French orchestra conductor, Pierre Monteux. This consumed his free time for the next five years and perfected his skills as a conductor.

At Oberlin Cal had been exposed to the choral techniques of Olaf Christiansen for one year. Now he was to work under Robert Shaw and Roger Wagner, the master of Renaissance and Polyphonic music, and his disciple, Paul Salamunovich.

From 1950-65 Cal Rogers served Akron Symphony Orchestra as Concertmaster and Assoc. Conductor. He is currently Concertmaster Emeritus of this orchestra. From 1963-65 he was also Conductor of the Wooster Symphony. From 1979 to 81 he was Conductor of the Ashland Symphony Orchestra and the Mansfield Symphony Orchestra Chorus. This summer he will have finished several years of distinguished playing as Concertmaster of the Lakeside Symphony.

He has held a guest lectureship at the College of Idaho and guest instructorships at the U. of Wisconsin and Miami U. The demands for his services as clinician, adjudicator, and guest conductor of vocal and instrumental groups far surpasses his available time.

In 1981-82 Professor Rogers taught at Keimyung University in Taegu, South Korea on a Fullbright Lectureship. While there he performed as a violin soloist throughout Korea and

guest conducted the Pusan Symphony Orchestra.

In 1975 Cal Rogers received the coveted Distinguished Service award of the Ohio Music Education Association. Ashland Chamber of Commerce has presented him with a Certificate of Gratitude for "helping to foster the cultural growth of Ashland".

His Ashland College Choir's first prize at the International CHORBEWERB in Spittal, Austria in 1981 remains only the second first prize awarded to an American Choral group in the history of the competition. His biography appears in the 7th and 8th editions of International Who's Who in Music and

Musicians.



SALAMUNOVICH TO BE CLINICIAN

Don Bogards of Columbus invites all OCDA members to attend the Augsburg Publishing Houses's Church Music Workshop to be held Monday and Tuesday August 13 and 14 at the Worthington United Methodist Church, Worthington, Ohio.

The featured choral clinician for the two day event will be Paul Salamunovich of Loyola-Marymount College, Los Angeles, CA. On Monday Sam Batt Owens of Memphis, Tennessee will conduct handbell and choral sessions. Larry A. Smith of Bloomington, Indiana will add pertinent sessions on organ performance in the worship service. Registration is at 10 on Monday, and the day will conclude at 8:30 p.m. Tuesday hours are from 9 to 4.

OHIO SENIOR CITIZEN'S CHORUS TO BE FORMED

A statewide senior citizen concert chorus is being formed under the direction of Lloyd Savage, retired choral director, Chillicothe Public Schools, Ross County. It is to be funded jointly by the Ohio Commission on Aging and the Columbus Recreation and Parks Dept.

The concert chorus will be made up of four individuals from each of Ohio's 88 counties. One soprano, one alto, one tenor and one bass will be selected from each area after a series of auditions have been conducted throughout the state. Candidates must be 55 years of age or older, retired, or working only part-time. Persons interested in joining the senior citizen concert chorus must first audition.

Individuals are responsible for purchasing music for the auditions. The selected songs are "Now Let Every Tongue Adore Thee," Bach, E.C. Shirmer arrangement; Every Time I Feel The Spirit," Dawson Tuskogee Press; and I Wonder As I Wander," Niles G. Shirmer arrangement. These are available at Stanton's Sheet Music.

This new chorus will make its first appearance at the 1985 Ohio State Fair. Regional rehearsals will be a half-day each month. Mass rehearsals will be held four times a year at the Martin Janis Senior Center, Columbus.

Further information and audition forms are available from Ardath H. Lynch, chorus coordinator and the Martin Janis Center or at Coyle Music Centers and Stanton's Sheet Music in Columbus; Coffman's Music in Lancaster; Martin's Music Center in Newark.
