14-16, 1986. A Planning Committee chaired by Herb Henke, Professor of Music Education at Oberlin, has been hard at work. Members of the Committee are OCDA President Neil Davis, Kitty Jarjisian, Carol Longsworth, Jessie Reeder, and Eric Richardson.

In the Spring Newsletter you read about our plans to emphasize masterwork repertoire and interpretation. All styles will be represented with Daniel Moe, Professor of Choral Conducting at Oberlin, leading our performance-study of the classics which the OCDA membership requested in last fall's survey. Conducting and interpreting representative spiritual and gospel works will be Jessie Reeder, Director of Vocal Music 6-12 for the Oberlin City Schools. And Professor James Gallagher, Ohio State University, will present a session on vocal jazz techniques. Besides the repertoire being studied under these three expert clinicians, there will be reading sessions and exhibits of selected editions of secular and sacred compositions for participants to add to their repertoire collections.

A variety of satellite sessions and activities will surround those described above. The Planning Committee is pleased to announce that Dr.Karen Wolff, Associate Dean and Director of the Cincinnati College-Conservatory of Music Children's Choir, will present a session on middle school choirs. Dr. Wolff joins Oberlin Professors Judith Layng (Opera Theatre) and Herbert Henke, and Oberlin Community Chambers Singers Director

Carol Longsworth on the list of clinicians.

Church choir directors may be especially interested in an exhibit by the American Hymnology Society which has established its archives at Oberlin. Mary Louise VanDyke will arrange the exhibition and be available to discuss the hymnology work being done at Oberlin.

David Boe, Dean of the Oberlin Conservatory, and Singing Professor Daune Mahy will join forces to present an organ and voice recital on Thursday evening. Both have concertized widely both in the United States and abroad. As previously announced, OCDA Past-President John Drotleff will conduct the West Shore Chorale in a concert on Friday evening. And

highlighting the Conference Luncheon on Saturday will be a delightful performance by the "Bag Ladies", a singing group you

won't want to miss.

With the first session of the Conference beginning at 2:00 P.M. on Thursday, Aug. 14, and the final session ending by 3:00 p.m. on Saturday, Aug. 16, you can anticipate 49 hours of choral music-making, choral music study and examination, concert listening, and sessions on choral rehearsal techniques, staging, programming, and vocal development. There will be opportunities for renewing and establishing friendships with choral directors from all over Ohio.

Despite the fact that you probably won't find time for much rest, attending the OCDA 1986 Summer Conference at Oberlin will provide refreshment and professional renewal just before the start of another academic or church year. Pre-register now!

Historical Facts on ACDA

Ever since I became a member of ACDA in 1970 (which by the way was when Robert Shaw was the speaker and clinician in Dayton, OH.) the main goals of our organization have been to increase membership and encourage more involvement from choral directors. The realistic approach would be to consider the benefits that can be gained by joining ACDA and the image that we project. Benefits are numerous and begin with three fine publications, THE CHORAL JOURNAL (national), RESOUND (divisional) and OCDA NEWS (state). All are filled with informative articles, repertoire, methods, techniques and inspirational advice. There are conferences, conventions and workshops where we can meet our colleagues, make new friends, exchange ideas and grow professionally.

Perhaps our image needs improving, since some people are still not aware that ACDA is for directors at all levels and areas of choral music. From the beginning ACDA has included all aspects of choral music; elementary, junior high, and senior high schools, college and university, as well as church and

community choirs.

Since we just celebrated the 25th anniversary of ACDA in 1985, here is some appropriate historical background on the national organization as well as our own state. The following information comes from a doctoral dissertation on the history of ACDA by David Bauer, Kearney State College, Kearney, Nebraska.

"It is a misconception that ACDA was a part of MENC. ACDA has never been a part of MENC. In fact, ACDA first met during a MTNA convention in Kansas City, February 24, 1959. Elwood Keister provided the name for the association. Harry Robert Wilson wrote the original ten purposes, which were extended to twelve during the 1970's in the ACDA Constitution. Archie Jones was nominated as the first president. ACDA's first national conference met the two days prior to the 1960 MENC national convention in Atlantic City.

"The first divisional conventions were held in 1961, also two days preceding MENC conventions. The only exception is the North Central's first convention which was in 1963. Divisional chairmen (presidents) were not appointed until 1961. The Central Division was not created until 1980. Prior to that date,

Ohio was a member of the North Central Division.

The first totally independent divisional convention was held October 15, 1966 (Western Division) at Occidental College in California. Beginning in 1970, all divisions held independent Conventions. The first independent national ACDA convention

was held in Kansas City, Missouri in 1971."

According to our Ohio Choral Directors Association historical records from convention programs and "NEWS", Ohio state presidents were: Ferris Ohl* (1960-64), R. Byron Griest (1964-66), Hamer Mitchell (1966-67), Ernest Hisey (1967-68), George Wilson, (1968-70), John Van Nice (1970-72), Lawrence Tagg (1972-74), John Williams (1974-76), William Hamilton (1976-77), Maurice Casey (1977-78), Calvin Rogers (1978-81), John Drotleff (1981-85), B. Neil Davis (1985-present).

In 1965 the first Ohio ACDA reading session was held at the OMEA State convention with Byron Griest as chairman. The first Summer Convention of Ohio ACDA was held at Baldwin-Wallace College in 1967. Ernest Hisey was state chairman and Maurice Casey was the convention chairman. In 1981 we became known as Ohio Choral Directors Association.

Our history shows much growth and development under dedicated leadership and the diligent work of its members. Let's continue to promote this fine organization and strive for

excellence in all our choral activities.
