Oct. 23 - 24 You Are Invited! OCDA Fall Conference Denison University

We hope to make the OCDA fall gathering in Granville a unique experience. The idea of immersing ourselves in a lot of wonderful Christmas music surrounded by glorious autumn foliage may seem unusual enough to start with. So-why not a pair of clinicians who are not professional choral conductors?

Tina Chancey and Scott Reiss are noted performers from Washington, D.C. who have dazzled audiences in Granville and across the country through their artistry as members of The Folger Consort, a medieval and renaissance ensemble in residence at the Folger Shakespeare Library, and Hesperus, the early music ensemble in residence at Georgetown University. They have also, in Granville and elsewhere, presented themselves as able and attractive teachers to the most diverse

sorts of audiences. Their interests now extend from the Middle Ages to traditional music from Appalachia and Ireland, as well as various kinds of crossover idioms.

The Washington Post announced on February 23 that they "fiddled and plucked and blew and drummed and occasionally danced with a contagious pleasure that had the audience tapping their feet and sometimes singing along." They will infect us with that contagion at the demonstration concert on Friday evening and then on Saturday morning explain and demonstrate how we can adapt early music to our own use.

Dr. William Osborne, chairman of the conference, will conduct the 7:30 opening reading session which will center around accompanied Christmas works of 10 to 15 minute lengths.

Saturday will include music for children with Sandy Stegman, a panel discussion of constitutional questions affecting choral directors, and another reading session with Leman, Raridon, Mix and any loyal OCDA director who brings 50-60 copies of music to sing.

Girls Glee Clubs Invited To Indiana

An interesting invitation has been extended to Ohio Women's Choirs. The Saint Mary's College Department of Music (Notre Dame, IN) will host the third annual High School Women's Choir Festival on January 21 and 22, 1988 on the college campus.

Commentators for the event will be Dr. Robert Harris, Director of Choral Activities at Northwestern University in Evanston, Illinois; Dr. James Laster, Director of Choral Activities at Shenandoah Collage and Conservatory of Music in Winchester, Virginia; and Dr. Patricia Cahalan, Director of Choral Activities at Manchester College in North Manchester, Indiana.

Each participating choir will perform a program of 15-25 minutes and will receive written evaluations from two commentators. A third commentator will work with each choir for 10-15 minutes following their performance.

The choirs will perform for each other during the morning and afternoon sessions, and lunch will be provided by the Saint Mary's College Department of Music. The day's events will also include a tour of the campus and a performance by the Saint Mary's College Women's Choir.

Help Needed At North Coast Convention Children's Chorus Events

Several exciting events in the area of children's chorus can be anticipated at the North Coast Central Division Convention in Cleveland this March. Two special attractions are performances by the Chicago Children's Choir Treble Ensemble under the direction of John Uhlenhopp and the Glen Ellyn Children's Chorus directed by Doreen Rao. Anton Armstrong will guest conduct the Festival Children's Chorus. At this event, each state will be represented by a children's chorus that will create a combined ensemble of over one hundred young singers and perform a diversified program.

Special clinic sessions will include "Musicals for Adolescents," "The First 30 Days - Jr. High/Middle School Choir," "Choral Development through Attitude in Junior High," "Building Junior and Senior High School Choirs in the Church," and a panel presentation and discussion on "The Changing Voice." A reading session of children's literature featuring music that is highly recommended by some of the region's most prominent directors of children's choirs is also scheduled.

The Central Division Convention is providing programming of particular interest to directors of children's choruses. Interested persons can support this endeavor in two specific ways: 1) by attending these conference sessions and bringing a colleague along, and 2) by volunteering to assist with some of the behind-the-scenes organizational duties. One specific need is providing guides and escorts for the various guest choirs involved. No one person could manage the comings and goings of all of these choirs, but many people volunteering just a few hours of their conference time to serving as an escort would make this a manageable undertaking. Anton Armstrong Conductor



Anton Armstrong, conductor and music educator is currently Associate Professor of Music at Calvin College where he is in his seventh season as Music Director and Conductor of the Calvin College Alumni Choir. He also holds the post of Conductor of the Grand Rapids Symphonic Choir, the 120 voice choral ensemble of the Grand Rapids

Symphony Orchestra.

Dr. Armstrong is very active in the area of children's choral music. He is conductor of the St. Cecilia Youth Chorale, a 75-voice treble chorus based in Grand Rapids. During the summer months he serves as Director of ALBEMARLE, the coed summer music program of the American Boychoir (formerly the Columbus Boychoir) in Princeton, New Jersey. He has also conducted as a guest, summer youth choruses at the University of Illinois and the University of Michigan-Flint and St. Olaf College.

Dr. Armstrong is a graduate of St. Olaf College, earned a Master of Music degree at the University of Illinois, and received the Doctor of Musical Arts degree at Michigan State University. He has been listed in the 1983 Who's Who in American Music and the 1984 and 1987 International Who's Who in

Music.

In recent years, he has conducted the Utah All State Chorus at the Salt Lake Morman Tabernacle, choral ensembles of the Interlochen Arts Academy, as well as choral festivals in Canada and the British Virgin Islands. Guest conducting and lecturing appearances in 1987-88 include choral festivals and conferences in Indiana, Michigan, Minnesota, Ohio, California, and the National Conference of the American Orff-Schulwerk Association in Chicago, Illinois.

"Women Composers of Choral Music"

Carol H. Longsworth of Oberlin will present an interesting discussion and reading session on women composers on Thursday afternoon of the Central Division Conference. She is well qualified to speak to this subject for she has been the director of the Oberlin Community Chamber

Singers since 1967.

During their 20th anniversary year they commissioned a work by Alice Parker. This "Song of Praise" will be performed at their Christmas Concert. At their spring concert they did an arrangement of "Night and Day" by Oberlin composer Ed Miller created especially for the 20 voice auditioned ensemble's anniversary.

Carol Longsworth graduated from Duke Univ. in Music Ed and received her Master's Degree in Church Music from New England Conservatory. She was a Rockefeller Scholar at Harvard Divinity School. She has taught in public schools in North Carolina and Ohio and was Acting Director of Choirs and Lecturer in Music History at the College of William and Mary, Virginia in 1983.

She is the new Co-ordinator of Environmental Studies at Oberlin College besides being Director of Music at First Church, U.C.C., Oberlin.

Audition for OHC



Ohio Honors Chorale Concert Europe

General Information

What is this group? What is its purpose? What does it do? It is a Concert Choir of Ohio High School students, participants in their school vocal music programs, who have been chosen for membership in this select touring-choir through private audition. Its purpose is to introduce its members, through a fine concert tour, to some of Europe's historical centers, people, and cultures; to aid in the growth of better appreciation, understanding, and love of our fellow-man. Through our concerts, home-stays, and other personal contacts with our audiences, we believe we that we come closer to mutual understandings that will benefit us all.

Is the Chorale a sponsored group? What are the costs? The Chorale is a non-sponsored, non-profit activity! Each member is personally responsible for costs involved. The costs are listed in the official brochure, and are detailed in the information available from your source of this application form, or from the director of the Chorale.

Who may apply for membership?
Any bona fide high school student, a member of their school's vocal music program, who receives the recommendation of their H.S. Choral Director, and of the school Principal. Because of the vocal, and social demands of the tour, preference is given to members of the 11th and 12th grades. Membership is limited to a maximum of 48 singers.

What are "auditions"? Where are they held? When?
The applicant sings a solo of their choice, before a panel of the staff members, and is tested upon sight-reading, general musicianship, and evaluated for personality. Auditions are held at Grove City, Ohio high school. See other side for details.

What is the schedule, and itinerary for the 1988 tour?
Anticipated dates are June 21 to July 12, 1988. Expected itinerary includes Frankfurt, a Cruise on the Rhine, Mannheim, Munich, Nurenburg, and Wurzburg in West Germany; Strasbourg, Colmar, Lyon, Marseille, and Nice, in France; Basel, Bern, Lausanne, and Geneva, in Switzerland; Genoa, Florence, Bologna, Venice, Padua, Verona, and Bolzano, in Italy; Innsbruck, and Salzburg, Austria.

Who are the directors of the Chorale?
All members of the staff are present, or former, Ohio H.S. Choral Directors, members of the Ohio Choral Directors Association, and of the National Music Educators Conference, selected because of their successful teaching careers. See information sheets for listing of staff members.

Will your school be represented this year?
That depends upon you!! Talk to your family, and talk to your choir director about it. It starts by submitting your application!

Sight Singing? Oh, Yes!

"Teaching Sight Singing to High Schoolers within the Rehearsal" is the topic Dr. C.M. Shearer, Director of Choral Activities at Kent State Univ., OH, will speak about on Thursday afternoon. He is co-author of "Sight Singing Part Exercises" and "The Jensen Sight Singing Course", both published by Jensen.

With over 90 published choral compositions Dr. Shearer has distinguished himself as a conductor, composer, and clinician. He has prepared choruses for the San Antonio Symphony, Mexico City National Symphony, and the Corpus Christi, Victoria, and Canton Symphonies. He has prepared orchestras and choruses for such noted composers as Alberto Ginestera, Krystof Penderecki, Ned Rorem, Robert Ward, and David Ward-Steinman.

He has conducted numerous choral festivals and all state choirs. His bachelor's and master's degrees are from North Texas State Univ.; his Doctor of Musical Arts from the Univ. of Colorado at Boulder. He has served as Chorusmaster for Opera/Omaha and Corpus Christi Symphony.

No More Guessing!

A Review by Beverlie Mayer

At last help has come for the many choral directors who have learned their Latin for choral singing from someone else who learned it from someone else, who learned it from etc. etc. Over the many years I have been involved in choral singing I have heard Classical Latin, Church Latin, mish-mash as my mother with a Master's Degree in Latin taught it Latin, and every kind of Latin pronunciation conceivable. Now there is a small neat book out of University Press of America which EVERY choral director and singer should own.. It is:

"THE CHORAL DIRECTOR'S LATIN" by Ivan Trusler The first three chapters are guides to pronunciation of Vowels, Consonants, and Compound Sounds. Webster pronunciation and International Phonetic Alphabet are used. However, it is Dr. Trusler's very clear discussion of the sounds that make it so practical.

For example: After saying spelled e is sung EH and giving English words to say, he describes exactly what the tongue and upper lip do to make the sound. Then he goes on to explain that Deus must be sung "Deh-oos", not "Day ih-oos". Miserere must be sung "mee-seh-reh-reh", never

"mee-say ih-ray-ih-rayih".

I opened the book to Chapter Four. Randomly I turned to Psalm 150. First there was a brief, to the point description of what the style of this "poetic prose" consists. Next is given the Latin text, followed by the phonetics, and the English translation. Quickly you have every thing needed to teach the words and subtle meaning correctly.

Do you know which is correct: "glaw-ree-ah" or "gloh oo-ree-ah"? If you have any doubt you need

this book. 'Nuf sed!

Men's Chorus Festival Director

Morris D. Hayes is professor of music and director of choral organizations at the University of Wisconsin-Eau Claire. He is considered an authority on the training and development of male voices and perhaps is best known for his role as conductor of the UW-Eau Claire men's choral group, the Singing Statesmen.

Under Hayes' direction the Statesmen have toured extensively in the United States and have presented concerts in Norway and Sweden, at the national convention of the American Choral Directors Association, and formed the first national high school youth chorale to perform in the

People's Republic of China.

Hayes has conducted honor choruses in 17 states. A former president of the American Choral Directors Association, Hayes was named in 1985 to receive an award from the national organization for distinguished service and leadership. That same year the Wisconsin Choral Directors Association (WCDA) named an award for outstanding choral direction in his honor and presented him with the first award. Hayes helped form WCDA and served as its first president.
